#### FEE SCHEDULE

##### TAX RETURNS – PRICED BY THE FORM:

Business Return Forms: 1120, 1120-S, 1065, 1041, 990, 706, 709 start at \$1,200

- Form 7004, etc. Business Extension, electronically filed - \$95

Personal Return Forms: Federal Individual Form 1040 – starts at \$250

Schedule A, B, Form 2441, etc. Additional Forms and Schedules, as required - \$85 each

- Schedule C and F Businesses - start at \$200
- Schedule D – Capital Gains and Losses with Form 8949 start at \$100 each
- Schedule E – Rental Property and Flow-Through Entities – start at \$100 per property and entity

Estimated Tax Federal and State Forms - \$150 each

Amended returns Forms 1040X, with state and electronically filed (as applicable) – \$450 plus additional forms as needed.

All States – start at \$125 each
